



Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is considered extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state and local governments as well as federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. Even now with some of the restrictions being lifted, the common thinking is to still practice social distancing as much as possible.

Solid Rock and The Rock Teen Center (*"The Rock"*) have put in place preventative measures to reduce the spread of COVID-19; however, *The Rock* **cannot guarantee** that you or your family will not become infected with COVID-19. Further, **attending *The Rock* could increase** your risk and your (teen(s)'s risk of contracting COVID-19.

We are concerned about the health and well-being of all the teens, parents, siblings, volunteers, partners, and staff of all who enter our premises or are involved in some manner with *The Rock*. We want you to use wisdom and discernment regarding when and how your teen(s) re-engages in social settings to prevent the spread of COVID-19. We are putting in place certain protocols that we hope will minimize the potential to contract and/or spread COVID-19. These are precautions; not solutions, cures or guarantees against spreading or contracting this virus.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and assume the risk that my teen(s) and I may be exposed to or infected by COVID-19 by attending *The Rock* and that such exposure or infection may result in personal injury, illness, permanent disability, and/or death.

I further understand that the risk of becoming exposed to or infected by COVID-19 at *The Rock* may result from the actions, omissions, or negligence of myself and others, including, but not limited to, *The Rock* employees, volunteers, and program participants and their families.

I agree to assume all of the foregoing risks and accept sole responsibility for any injury to my teen(s) or myself (including, but not limited to, personal injury, disability, and/or death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my teen(s) may experience or incur in connection with my teen(s)'s attendance at *The Rock* or participation in *The Rock's* programming.

On my behalf, and on behalf of my teen(s), I hereby release, covenant not to sue, discharge, and hold harmless *The Rock*, its employees, agents, and representatives, of and from claims, including all liabilities, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of *The Rock*, its employees, agents,

and representatives, whether a COVID-19 infection occurs before, during, or after participation in any of *The Rock* teen center programs. I understand that any violation of these new precautions by myself or my teen(s) may result in a suspension from The Rock for the safety of others.

I am attesting that I don't have or have not had within the past two weeks, any of the following symptoms:

- 1. Fever of 100 degrees or higher
- 2. Cough or shortness of breath
- 3. Chills or repeated shaking with chills
- 4. Muscle pain
- 5. Sore throat
- 6. New loss of smell or taste
- 7. Body aches/fatigue
